

As we approach Wellness Week and Thanksgiving, a season of gratitude and reflection, I want to express my heartfelt thanks to each of you for your dedication, patience, and thoughtful feedback. This year, we have engaged in significant discussions about the future of our school facilities. These conversations are not merely about buildings—they are about ensuring that our students have environments where they can learn, grow, and thrive. As we approach a decision in the near future regarding the nine recommended schools, please know that our focus remains steadfast on what is best for our students. These decisions are not easy, but they are guided by our shared goal of providing equitable opportunities and resources for every child in our district.
